# **Keynotes**



### Simon Marginson, UK

Professor of the world-leading higher education research centers – the Institute of Education of the University College of London (UCL). Since 2015, he has held the position of the Director of the Centre for Global Higher Education. Professor Marginson is known for his works on the higher education internalization and globalization, comparative education, inequality in education, etc. Moreover, he is the author of such concepts as 'glonacal' (global/national/local) and Post-Confucian Model of higher education, as well as an idea higher education as a 'self-forming' process, which combines both the economic and non-economic practices.



### Marek Kwiek, Poland

Professor and Director of the Center for Public Policy Studies (since 2002) of Poznan University, and the UNESCO Chair in Institutional Research and Higher Education Policy. Professor Kwiek's area of expertise includes the international comparative higher education, the balance of the universities' global and local goals, the university rankings and the academic profession.



# Peter Maassen, Norway

Doctor Peter Maassen is Professor of the Department of Education at the University of Oslo, and the ex-director of the Center for Higher Education Policy Studies of the University of Twente. His strong professional interest is in the research of higher education. Professor's latest works focus on the international assessment of the higher education quality, the university staff's research efficiency and research universities.



### Giovanni Abramo, Italy

The round table will dedicated to discussion of the following issues:

# 1) Search for a new balance on the medical staff training market.

As we gradually transit to a new structure of the staff in medical institutions, with the developing non-government healthcare market and emerging related or completely new medical professions, as medical higher educational institutions become more popular among school graduates, we trace a quite unexpected imbalance between the medical higher educational institutions' graduation, supply and demand in the employment market. How will the medical staff training system and medical higher educational institutions respond to this situation?

2) Search for the implementation of the high-tech and resource-intensive medical training. The development of the modern medicine is first of all focused on the high-tech, all-time updated and expensive training of the future and already working medical staff. At the same time, the classical training models in higher educational institutions create a quite wide gap between learning and the high-intensity medical

practice, to the extent of which the technologies, the skills and the knowledge are updated continuously. Is it really possible to integrate education and a high-tech, high-intensity practice for training medical staff of the 21<sup>st</sup> century?

3) Search for the balance between global and local challenges in the development of medical higher educational institutions. One of the major global challenges for medical higher educational institutions is to expand and intensify the university research and innovations all over the world in a transition to the evidence-based medicine. It is obvious that the Russian higher educational institutions cannot ignore this trend. On the other hand, at the local level, medical higher educational institutions face to the necessity for adapting to the economic changes, as well as the ones in the HR and medical service markets. How do the Russian medical higher educational institutions respond to the global and local challenges?

The Russian and international experts, the representatives of medical higher educational institutions and organizations are also invited for taking part in the roundtable discussion.
